About Our Program:

- The Lady Bandits U16 team practices full ice, once a week.
- The Lady Bandits U14, U12 & both U10 teams practice half ice, twice a week.
- Practice days & times are reasonably consistent all season.
- All players receive one strength training session per week.
- The Lady Bandits U10, U12 & U14 teams receive (10) full-ice, 50 minute summer practices.
- The Lady Bandits U16 team receives (5) full-ice, 50 minute summer practices.
- All home games and practices are held at the Bridgewater Ice Arena
- Players receive a week long (Monday thru Friday,) full day summer clinic, operated by Hub City Hockey.
- Goalies receive a summer goalie clinic instructed by Mike Doneghey, August 22nd thru August 26th.
- Throughout the regular season, goalies receive bi-weekly skills with Mike Doneghey.
- The cost of the 2010-2011 Lady Bandits Program is based on 17 players per team.
- If the coach elects to roster more or less than 17 players, tuition will change accordingly.
- Tuition includes: league games, playoffs, 2 practices per week, home and away socks, practice jerseys, helmet stickers, league fees, referees, timekeepers, and team administration.
- Additional tournaments, USA hockey fees, game jerseys & gear bags are not included in tuition.

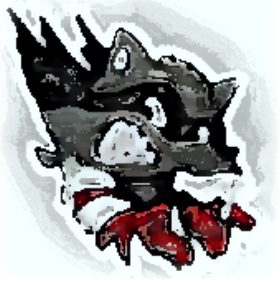

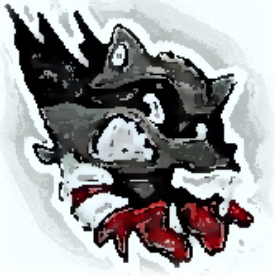
